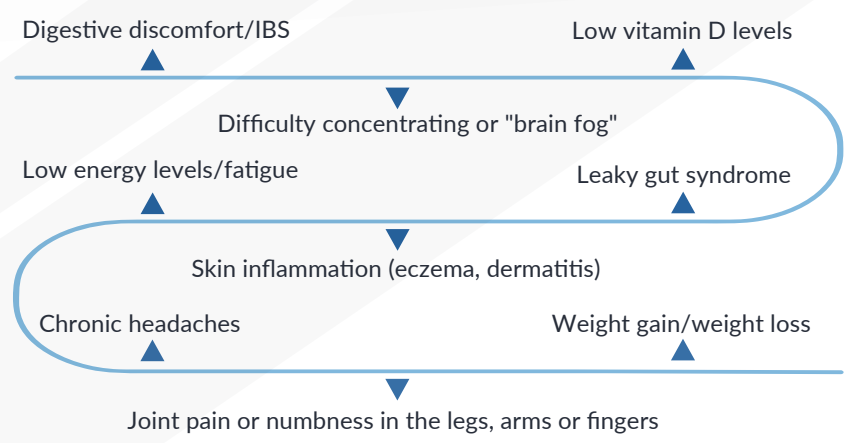
▶ What is wheat/gluten sensitivity?

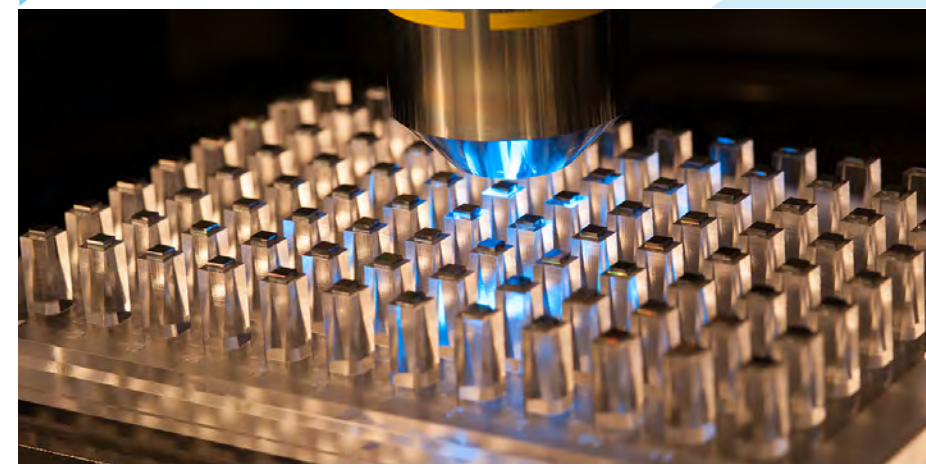
